DUES: Dues for the 2017 season are \$80.00. New Vendors, first year is \$50.00. Monthly Crafters: \$50.00. Guest Vendors/Crafters fees are \$10.00 per market day, \$25.00 for four consecutive weeks, or \$80.00 for season. Dues are payable with the application or by payment plan. Payments due 1st market day.
